Notice is hereby given that a **Special Town Meeting** of the Town of Liberty Grove, Door County, Wisconsin, will be held in the Town at 11161 Old Stage Road on the 16th day of October, 2018 immediately following the hearing on the proposed 2019 budget, which begins at 7 PM, for the following purposes:

1. Authorize the Town Board to purchase land—Wis. Stat. 60.12(e), parcels 018-03-06322921A3, 21A5 and 21F.
2. Consider adoption of a resolution (resolution attached to this notice) by the Town Meeting endorsing a Town Board resolution which proposes that the Town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable Town tax levy for 2019 by 34.3% which would be a dollar increase of \$598,639.76 over the allowable levy for 2019. This increase shall be ongoing.
3. Adopt the 2018 total Town tax levy to be collected in 2019 pursuant to s. 60.10(1)(a) of Wis. Statutes, that amount to be \$2,344,187.76.

**Town of Liberty Grove Resolution # 8-18
Increase in levy over state imposed limit**

Whereas, the State of Wisconsin has imposed levy limits under s. 66.0602 of Wis. Statutes for the tax levies in 2017 and thereafter;

Whereas, Sec. 66.0602 of Wis. Statutes allows the town electors in towns under 3,000 in population to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of the electors;

Whereas, the town board has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Liberty Grove;

Whereas, this special town meeting of the electors has been called and noticed to consider the adoption of a resolution to endorse the town board's resolution to exceed the state levy limits; specifically by increasing the allowable town tax levy for 2018, collected in 2019 by 34.30 percent;

Now, therefore, the special town meeting of the Town of Liberty Grove, Door County, Wisconsin, by a majority vote of the eligible electors voting on this 16th day of October, 2018 duly assembled and voting resolves and orders as follows:

BE IT RESOLVED, the town electors of the Town of Liberty Grove, Door County, Wisconsin endorse the Town Board resolution to increase the Town tax levy for 2018 (collected in 2019) by 34.30% over the allowable 2018 levy, which is an increase of \$598,640 over the allowable 2018 town tax levy. This increase shall be ongoing.

The town clerk shall properly post this resolution in 3 places or publish this resolution once in a newspaper as required by law under s. 60.80 of Wis.Statutes within 30 days of adoption.
