Liberty Grove Parks

Port des Morts Park

This park, located at 12832 Kenosha Rd, offers a great view of Death's Door. Equipped with a picnic table, bench and grill you can take a leisurely break from reality. There is also a staircase down to the water. Take Hwy 42 north beyond where the highway turns to the east. Turn left on Kenosha Dr. and take it to its end

Wisconsin Bay Park

Take Timberline Rd. north of Hwy 42. As the road bears to the left look for a gravel entrance to the right. There is a small parking area, picnic table and park grill. Enjoy the beautiful view of Death's Door. 740 Wisconsin Bay Rd.

Gills Rock Park

Located at 12724 Wisconsin Bay Rd at Hwy 42. This park is great for families. A covered picnic area, playground and park are close to the water for viewing. Dogs must be on a leash.

Fitzgerald Park

This park is at 1594 Old School Rd. Take Hwy 42 to Garrett Bay Rd and turn left. This park has a small playground, covered picnic area, a baseball field and in the winter an ice-skating rink. A large grassy area makes this a great place for family gatherings. Dogs must be leashed.

Wills Park and Marina

The park and marina are located at 12033 Cedar Shore Rd, just west of Hwy 42 in downtown Ellison Bay. Daily launching is permitted upon payment of launch fee. Overnight docking is available on a limited basis. Contact (920)421-1974 for permission. Come and watch the beautiful sunsets from this park. Dogs must be leashed.

Hotz Memorial Town Park

At the eastern end of Europe Bay Rd you will find the right spot for a family picnic and a swim in Lake Michigan. This park has picnic tables, grills and bathrooms. Take Hwy 42 north to Europe Bay Rd. Turn right and stay on it as far as it goes. Dogs are not allowed on the beach. 349 Europe Bay Rd, Ellison Bay. Non-motorized launch at the north end of the park.

Ellison Bay Community Park

Also known as "The Women's Club" it is located at 11953 Hwy 42 at the south end of downtown Ellison Bay. This is a great family park with sandy beach, swimming, picnic areas with grills, a gazebo, playground facilities and bathrooms. No dogs allowed in beach area. Non-motorized launching on rocks west of pier.

Sand Bay Town Park

To find this hidden treasure head east on Waters End Rd. just about to its end. Turn left on N. Sand Bay Lane, a short drive and turn to your right and you will find a sand beach, swings, picnic area and bathrooms. At the north end of this park there is an area to launch kayaks. Dogs are not permitted on the beach. The address is 11154 N. Sand Bay Ln, Sister Bay. Non-motorized launching at far north end of park.

Isle View Park

Located at 167 Isle View Rd this small picnic area overlooking Lake Michigan waters. A picnic table and park grill is there for your use. Take Hwy 42, turn right on Isle View Rd and take it to the end.

Garrett Bay Park

The Garrett Bay Park is located at the northwestern part of Garrett Bay Rd, 1310 Garrett Bay Rd, Ellison Bay. A quiet sports launch area is available with parking across the street. This is also the site of one of the sunken ships on the Great Lakes.

Europe Lake Launch

A shallow launch for smaller boats, this is located at 460 Europe Bay Rd. take Hwy 42 to Europe Bay Rd., Europe Bay to Timberline Rd and turn left. This is approved for non-motorized watercraft.

North Bay Boat Launch

Follow North Bay beyond the black top road all the way to its end. The address is 9883 North Bay Rd. there you will find this launching area which may be restrictive due to water levels. Non-motorized watercraft may launch from this area.

Severe Weather/Loss of Power

In the instance of a power outage, the Town Hall has a generator. If you need to use a PC, or to fill water bottles, use of a restroom, the facilities are available to you during the day. In the case of an extended power outage arrangements will be made with Emergency Services and the office.

Replacement fire signs from the County

The County Board has changed the fees for fire signs. The initial sign, post and installation, is now \$75 and a replacement sign charge was added and is now \$25. It is NOT allowable to paint faded fire signs as this is a violation of the Ordinance. The painting of signs will incur the replacement fee and may also include a citation/forfeiture. The paint required for the fire signs needs to be a certain grade of paint for visibility in daylight/darkness. It is necessary for owners to pay the replacement fee as the Sheriff's Department and Emergency Services use these signs to locate the driveways/residences. Choosing your senior living lifestyle:

There are many different options for senior living, but some of the first things that you should consider are these questions:

- Age-Segregated Communities – are you the type of person that enjoys living with or around people of a similar age or are you one that would prefer to live in an environment where all ages are represented. Many facilities and communities have strict rules regarding the age limit – be it 50, 55, or 60. However, due to the move to include those who have disabilities may lead to these historically age-segregated communities accepting younger people who need assistance Independent Living Communities - these are similar to apartment buildings however all of the residents are over a certain age. Many of these facilities offer meals for residents but within the individual apartments there are often kitchenettes, refrigerators, pantries, etc.
- Assisted Living Communities – to qualify for Assisted Living, a person must meet physical or cognitive requirements which are called Activities of Daily Living (ADLs). These ADL's are tasks that are required for independent living, including: dressing, bathing, toileting, meal preparation, medication reminders, grooming, work, homemaking and leisure. The average cost of a care in an Assisted Living Facility is over \$3,500 monthly and most, if not all, is paid for by the families or the resident.
- Skilled Nursing Facilities – Many people mistakenly believe that Medicare will pay for long-term care in a nursing home. This is not true. Many facilities will accept Medicaid, but they can be hard to find because the beds fill up fast. There are also income requirements for Medicaid Care in facilities, which vary from state to state, but a good rule of thumb is that the person can't have income of greater than \$2,000. In some States spouses are penalized and in some they are not. You should check with your state to see what the requirements are in your state.
- Continuing Care Retirement Communities (CCRCs) – as the population ages most people prefer to “age in place” which is what a CCRC provides. CCRC's provide the spectrum of care – from independent living, assisted living, and nursing facility care without having to move to another facility and re-learn the politics of the facility. If a resident needs care higher than their current living arrangement allows then they can move to the next higher level, alternately if someone gets healthier they can move to a lower level of care without any increases in charges. However, most people who move into a CCRC are required to “invest” a large amount of money before they move. It is imperative that you read over the paperwork to see if these funds are refundable and what would happen to the space if it is no longer a good fit for your loved one.

Assisted Living vs. Long-Term Care: Exploring Your Options

Seniors have many options regarding to how and where they will spend their post-retirement years. That's a great thing in that the elderly get to choose the environment where they will be most comfortable and have their needs met in a professional and friendly manner.
