

**TOWN OF LIBERTY GROVE
ORDINANCE 4-10**

DAMAGE TO PUBLIC PROPERTY

The Town Board of the Town of Liberty Grove (hereinafter referred to as “the Town”), in the County of Door, State of Wisconsin, does hereby ordain as follows:

This ordinance #4-10 supersedes any and all previous ordinances pertaining to the subject matter thereof.

Section I.

- A. No person shall break, soil, deface, injure, remove or otherwise damage or tamper with any Town sign, or any traffic sign, signal or barricade placed, installed or erected for street or highway purposes, on any Town road, street, alley, highway, right of way or parking lot.
- B. No person shall break, soil, deface, injure, remove or otherwise damage any Town park property or structure including but not limited to monuments, ornamental structures, buildings, signs, tables, benches, or any Town trees, shrubs, plants, lawns or other natural growth.
- C. No person shall open, remove, operate, break, soil, deface, injure or otherwise damage or tamper with any Town vehicle or equipment, including but not limited to any vehicles or equipment used for or related to construction or emergency purposes, except with the consent of the Town.
- D. No person shall break, open, soil, deface, injure, remove or otherwise damage or tamper with any Town building, or any other Town structure or other public property.

Section II. Penalties

- A. Any person violating any provision of this ordinance may be fined not less than \$250 nor more than \$500, plus costs and disbursements of prosecution. Upon evidence of a violation a citation will be issued as provided in the Citation Ordinance previously adopted by the Town Board.
- B. In addition to penalties listed in Section II(A), actual costs of replacement of damaged property as listed in this ordinance, including but not limited to parts and/or labor, shall be assessed to the individuals found guilty of violating this ordinance.

Section III.

This ordinance shall take effect upon passage and publication as provided by law. Adoption of this ordinance by the Liberty Grove Town Board does not preclude the Town Board from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter. Issuance of a citation hereunder shall not preclude the Town Board or any authorized officer from proceeding under any other ordinance or law or by any other enforcement method to enforce any ordinance, citation or order.
